Counseling is a personal exploration of your life. You may be sharing very personal aspects of your thoughts and actions, which can bring about varying results. Entering into counseling may have positive and negative effects. There may be serious changes in your personal life and/or your decisions. These changes may impact people that are around you, such as family and friends.
