#### DESCRIPTION OF EDUCATION AND EXPERIENCE

I hold a Masters Degree in counseling from Western Michigan University. My emphasis in training there was in secondary school counseling and guidance with an additional focus on marriage and family systems. I completed 50 credit hours in the Masters Program including counseling theory, diagnosis, counseling techniques, counseling across the lifespan, marriage and family systems, sex therapy, group counseling, consultation, multi-cultural counseling, and ethics in counseling. I have provided individual counseling to students at Western Michigan University's counseling clinic and have provided secondary school counseling and guidance for the past five years in Kalamazoo Public Schools, Walled Lake Consolidated Schools, and Ann Arbor Public Schools. I now provide professional counseling with a limited license in my private setting.

#### DESCRIPTION OF YOUR PRACTICE

I provide school counseling and guidance for students in Ann Arbor Public Schools at the secondary level of education. I also provide individual, group, couples, and family counseling in my private practice. My primary mode of counseling in the school setting is Solution-Focused Brief Therapy. In private practice I primarily work from a Person-Centered philosophy at times incorporating elements of Rational Emotive Behavior Therapy, Cognitive Behavioral Therapy, and Solution-Focused Therapy. Ultimately, my belief is that clients have everything they need on the inside to work through any struggle. It is my role as a counselor to partner with my clients through therapeutic processes (counseling sessions) as one pillar in their journey to personal growth and healing.

#### FEE

I do not charge a fee for services provided to students in a school setting. I offer individual counseling services to clients in my private setting at a rate of \$100 per session (sliding scale available based on need). Couples counseling sessions cost \$100 per session. Cash or credit card (including HSA) payments are accepted prior to the start of any individual counseling session. Counseling sessions last one hour, including 45 minutes for therapy and 15 minutes for clerical/billing matters.
